Subject to the terms of this License, Grower is entitled to use the PINK LADY® trademark only in connection with fresh apples produced by the Licensed Cripps Pink Cultivar Trees. Use of the "Flowing Heart Logo" trademark is also authorized under this License. Grower is only authorized to use the PINK LADY® trademark in the form of one or more of the following phrases or logos:

Brandt's is the exclusive owner of the PINK LADY® set of trademarks in the United States and Mexico. This License does not grant Grower any right, title or interest in the PINK LADY® trademark, other than the right to use the trademark in accordance with this License. Grower will not attack, or do anything inconsistent with, Brandt's title to, and ownership of, the PINK LADY® trademark, and will not attack the validity of this License. Grower will not do anything that results in weakening the strength or commercial value of the PINK LADY® trademark. Grower will not infringe the PINK LADY® trademark, and will not induce, or contribute to any third party's infringement of the PINK LADY® trademark. To protect the PINK LADY® trademark, Brandt's will randomly monitor usage of the PINK LADY® trademark by all licensed Growers. Grower's infringement of the '880 plant patent or the PINK LADY® trademark, or any other failure to strictly comply with any requirement, prohibition, or condition of this License shall automatically and immediately terminate all Grower's rights under this License.

This License does not authorize the use of the PINK LADY® trademark with the Licensed Apples, or any other apples, that are imported or exported to or from the United States. Grower must enter into a separate royalty bearing trademark license to use the PINK LADY® trademarks with apples that are imported or exported to or from the United States, and all exported apples must use the "Flowing Heart Logo shown above. Brandt's retains all right, title or interest in the PINK LADY® trademark, and Grower receives no rights thereto other than the limited non-exclusive rights granted by this License. Grower will not attack Brandt's title or ownership of the PINK LADY® trademarks, and will not attack the validity of this License. Grower must always act in good faith to support and improve the strength and commercial value of the PINK LADY® trademark, including complying with reasonable requests from Brandt's in that regard. Grower must not infringe, or induce or contribute to any third party's infringement, of the PINK LADY® trademarks. Grower must not assign or transfer any rights under this License, except when Grower's interest in the land upon which the Licensed Trees are planted is transferred to a Subsequent Purchaser. Upon any such transfer of interest in the land, Grower must provide an original of this License to the Subsequent Purchaser, who must then contact Brandt's within thirty (30) days to obtain a new license issued in their own name.

Any failure by Grower, or any Subsequent Purchaser, to strictly and timely comply with any requirement, prohibition, or condition of this License shall immediately terminate this License, without notice, and all Licensed Trees and Licensed Apples will immediately become infringing trees and infringing apples, subjecting the Grower and/or subsequent purchaser to monetary damages, injunctive relief, and destruction of trees, apples, and packaging materials under U.S. patent and trademark laws. This License is governed by the laws of the State of Washington and the U.S., and all parties consent to the personal jurisdiction and venue of the U.S. District Court for the Eastern District of Washington and/or the Yakima County Superior Court.
